GUIDELINES FOR ABSTRACT SUBMISSION:

Abstract should contain maximum 500 words on the sub-themes of the conference with double spacing on A4 size and should cover the main objectives of your work and major findings in brief including three to five keywords. The complete name of author along with the e- mail id and institutional address in brief should also be given with the abstract. One can also provide the Reference/Works-cited.

Font size and margin

1. The text is in 12-point Times New Roman (for English) and KrutiDev (for Hindi) font.
2. The pages are of A4 size, with margins. Margins of pages should follow the following specifications.
 - a) Left margin - 1.5 inch. from edge of paper.
 - b) Right margin - 1 inch. from edge of paper.
 - c) Top margin - 1 inch. from edge of paper.
 - d) Bottom margin - 1 inch. from edge of paper.

Heading

1. Main Headings
 - a) Times New Roman, 16 Font size.
 - b) Capital and Bold.
 - c) Must be centered.
