3. The applicant must submit a duly filled application form along with:
 - Latest Income Certificate issued by the competent authority.
 - Copies of relevant supporting documents, if any.
 - Recommendation of the Tutor/Class Mentor/Head of Department (where applicable).

Application Procedure:

- Application forms are available in the College office and in the office of the Old Students' Association (OSA).
- The completed application form, along with all supporting documents, must be submitted to the OSA Office on or before **05-08-2026**.
- Incomplete applications or applications received after the due date shall not be considered.

The applications will be scrutinized by the **OSA Fee Waiver Committee** and financial assistance will be awarded strictly on the basis of **genuine financial need, academic performance and the recommendations of the committee**. The decision of the committee shall be final and binding. Students are encouraged to avail themselves of this opportunity and submit their applications within the stipulated time.
